Terms and Conditions

Security Deposit

A security deposit is required at time of pick-up and will be refunded within 30 days after Camper is returned, as long as, unit is returned clean, holding tanks are emptied, gas tanks are full and no damage was done to the vehicle. Damages, additional charges or disputes may further delay deposit refund. Deposit may be made by credit card. Security Deposit are as follow; \$3,000 for Prevost, \$1,000 to \$1,500 for Motorhomes, \$500 for Travel Trailers and \$300 for Pop Up Campers.

At the time of rental a credit card voucher will be authorized by renter to cover any additional damage, cleaning fee, downtime and used to remedy all repairs that are required to have the vehicle fixed and in normal operating condition. This includes but is not limited to out of service charges. Renter is responsible for 100% of all damage to the rented unit.

Service Calls

Customers are provided an emergency telephone number. In cases where a service call is required due to inappropriate use by customer of a unit's mechanical features, a service call fee will be charged at the rate of \$125/hour with a minimum charge of \$125. Tire Hazard Insurance maybe purchased at \$20 per day.

Payment Terms

Security deposit is required at time of pick-up. A deposit is required at time of reservation to hold your reservation. This deposit will be refundable up to 30 days prior to your rental. Any time after that the deposit will be forfeited. Cancellation within one week of rental period will result in the loss of the entire rental fee. Early returns are not refundable.

Full payment of rental contract is due at time of departure and may be made with credit card or cash. Personal and company checks must be approved 10 days prior to departure.

Major credit cards accepted: Visa, MasterCard, Discover and American Express. A deposit will be made at time of reservation to hold your reservation. This will be refundable up to 30 days prior to your rental. This amount will be applied to your rental fee. At time of pick-up a security deposit will be required. The balance of your rental fee is required at time of pick-up.

Awning and Roof

Absolutely no awning use is allowed.

No person or persons are allowed on the roof of the Recreational Vehicle.

Age Requirements

All drivers must be 25 (Twenty-Five) years of age or older, have a valid driver's license and proof of insurance.

Penalties and Charges

There will be a \$125.00 minimum charge deducted if the camper comes back dirty on the inside or outside. There will be a \$150.00 charge if the camper is returned w/out cleaning the holding tanks. We require that the camper come back looking the way it went out.

Insurance/Liability

All renters must provide proof of insurance before renting camper. Insurance coverage is the responsibility of the renter. Any damage occurred to vehicle will be the responsibility of the renter.

Renter is liable for all parking tickets & traffic violations. Renter is responsible for all Toll Charges. Report all accidents to Woody RV Rentals, LLC and police immediately.

Should a break down occur renter must notify owner for repair authorization and follow instructions provided by Woody RV Rentals, LLC. The customer is responsible for checking engine oil, fluids, lug nuts, wheels, tires and coolant levels at each refueling, as well as reporting mechanical failures immediately. Customers may be held responsible for mechanical damage due to negligence in vehicle operation or failure to provide normal maintenance. In the event the vehicle is in breakdown repair for 12 hours or more, through no fault of the customer, our responsibility to customer is limited to refund of daily rate or portion thereof. Radio, air conditioning, refrigerator, microwave, appliances, cruise control, generator malfunctions. etc are not considered breakdowns and no refunds are available for repair time to these items.

Hauling and Delivering

All Renters contracting Woody RV Rentals, LLC to deliver RV's, Travel Trailers or Pop-up Campers will be responsible for damage to the camper while under contract to deliver. This includes tire blow-outs, damage to the campers or property damage to the facility we will be delivering to.

Terms & Conditions

All provisions of our rental agreement apply to each rental. Renter will be required to sign this agreement at time of reservation. The rental agreement is available for review at any time prior to departure. 3 days is the minimum rental period. 4 days is the minimum rental period for holiday weekends. A \$25.00 fee will be charged for any weekend or holiday return.

No Mexico travel under any condition.

No smoking allowed in rented vehicles at any time. Lack of compliance may result in forfeiture of security deposit and/or a minimum charge of \$200.

1. Choice of Law. This Agreement shall be governed by and construed in accordance with the laws of the state of Texas.
2. No Partnership. This Agreement does not create a partnership Agreement. Neither party has the authority to enter into contracts on the other's behalf.
3. Entire Agreement. This is the entire Agreement between the parties. It replaces and supersedes any and all oral Agreements between the parties, as well as any prior writings.
4. Successors and Assignees. This Agreement binds and benefits the heirs, successors and assignees of the parties.
5. Modification. Neither this Agreement nor any of the terms or conditions hereof may be waived, amended, or modified except by means of a written instrument duly executed by both parties.
6. Captions and Headings. The captions and headings used in this Agreement are for convenience of reference only and shall not affect the construction or interpretation of this Agreement or any of the provisions hereof.

7. Disputes and Forum. If a dispute arises, outside of those governed by Section 8 of this contract, the parties agree to try in good faith to settle it through mediation upon written notice by either party. Within ten (10) days of receipt of the written notice, Woody RV Rentals shall provide the Owner with a slate of three mediators. Within five (5) days of receiving the slate of mediators, the Client shall then choose one of the mediators on the slate. The location of mediation shall be Round Rock, Texas. The parties will share the costs of the mediator equally. Each party will cooperate fully and fairly with the mediator and will attempt to reach a mutually satisfactory compromise to the dispute. If the dispute is not resolved within thirty (30) days after it is referred to the mediator, either party may initiate court proceedings.

All court proceedings relating to this Agreement or the relationship between these parties shall be filed in Williamson County, Texas. The party prevailing in such litigation shall be entitled, in addition to such other relief as may be granted, to its reasonable attorneys' fees, expenses and costs.

This provision shall survive the expiration or earlier termination of this Agreement.

All rentals are scheduled for pick-up and return to 4550 S IH35, Georgetown, TX, 78626. Please Call Ahead. Appointment only! Unless other arrangements have been approved by owner.

The unit will be checked out completely as to operation and condition with you before departure. At time of check out, all vehicles will have propane, gas, holding tanks will be dumped and the interior and exterior will be clean.

Allow at least one (1/2) hour for check out.

Upon return, the vehicle will be inspected. This will NOT be considered the final inspection. The interior and exterior are to be clean and all personal belongings removed. The owners will not be held responsible for items left in vehicles at time of return. Based on the condition of the rental unit at the time of return, the appropriate charges will be applied against the security deposit. In the case of damage to the unit, proper documentation will be made at time of return. Allow at least half (1/2) hour for check in.
